



Sterling Youth Ballet, established as a non-profit ballet company, offers an opportunity for select ballet dancers to become part of a diversified group training as pre-professionals.


Our goal is to provide SYB members classical and contemporary performance opportunities, while promoting and developing community understanding and appreciation of dance and musical arts.






